This document is an electronic record in terms of existing and applicable Information Technology laws and the amended provisions thereto pertaining to electronic records in various allied statutes as amended pursuant to the Information Technology laws. Preliminary Information:

www.creditsudhaarfinance.com (Hereinafter referred to as the 'Website') is a website registered in the name of and being operated by Credit Sudhaar Finance Pvt. Ltd., a company incorporated under the provisions of the Companies Act, 1956, having its registered office at 303, Ruby Crescent Business Boulevard, above Axis Bank, Ashok Chakravati Road, opposite Kandivali Flyover, Kandivali East, Mumbai- 400 101, through its authorized representative, Jigar Gandhi s/o Dinesh Gandhi r/o Mumbai, Maharashtra and is hereinafter referred to as the "Company". The use of the Website is subject to the terms of the instant agreement.

The following terms and conditions will be deemed to have been accepted by the User, on mere usage of the Website and hence the User is required to read them carefully before using the services on the website, www.creditsudhaarfinance.com.

DEFINITIONS:
